Jamie Stevens of Dover Takes Helm of NHWWA as New Chair

Outgoing Chair Chris Berg passed the gavel to incoming Chair Jamie Stevens at the NEWWA/NHWWA Joint Meeting in Bedford on January 16. Jamie has served as a Director on the NHWWA Board since 2020 and is eager to help guide the Association through 2025.

Jamie started his career with the City of Dover over 23 years ago. Currently, he is the Construction Project Manager. He oversees the construction, inspection and testing processes of City utilities. He

ensures contractors adhere to expectable installation processes of each utility, water, sanitary sewer, stormwater, roadways, and sidewalks, as well subsurface electrical and telecom.

Before holding his current position, Jamie performed the duties of Lead Operator for the City's water treatment and waste water pump stations. His achievements include NH drinking water distribution Grade 3, NH drinking water treatment Grade 2, NH sewer collections Grade 4, and Master Road Scholar and Safety Champion. He previously oversaw the city's 2.1 MGD demand that is supplied through 7 production wells, 4 drinking water treatment plants, two storage tanks and one booster station. In addition, Jamie also oversaw the maintenance and operations of the City's 23 sewer pump stations.

Jamie is a lifelong resident of Dover where he resides on a small family farm (Stevens Family Farm) with his wife Samantha, three children and black lab, Scout. They raise pigs, turkeys, chickens and egg laying hens. They also produce maple syrup. He has also served as president of a local girls' softball league for the past 11 years. Jamie's coaching has extended over 20 years from softball into football, lacrosse and baseball where he



enjoys his passion for coaching and mentoring the City's youth. Jamie is also a three-time recipient of the "Heylinger Award" for exceptional volunteerism in youth sports. When he finds some time free from work, farming or coaching, he enjoys going hunting and fishing.

Legislative Update - 2025 Session

As we geared up for this 2025 legislative session, we were really expecting a slow year. There were a couple of reasons for this thought, mainly because it's a budget year and historically these years have a low number of Legislative Service Requests (LSRs). The NHWWA Legislative Committee is following 18 LSRs. That's a large amount of legislation, but note that these are covering everything from housing, medical, roads and municipal. Everything under the sun gets submitted as an LSR first before becoming a bill. We sift through and follow any LSRs related to water.

If you are a part of our legislative advocacy community in NHWWA, you receive emails about all the bills we are following. If you are not a part of our legislative advocacy group, I recommend doing so as you will be ahead of the rest in knowing what is in our future for water legislation and staying up to date with the bills that our Legislation Committee follows.

- ◆ Municipal and Private membership: \$0.18 per service connection
- ◆ Small Community Water Systems: \$150.
- ◆ Support membership: \$300 per year (vendors, professional firms).

NHWWA has attended a lot of hearings this session. Hearings give us the opportunity to hear the prime sponsors explain their piece of legislation in detail, followed by a portion of time

where people can speak for or against the bill. I think it is important to know, too, that during this meeting process it's a numbers game. What most House and Senate committees look at is the number of people for and opposed to a bill. These numbers mainly come from associations like ours that submit on behalf of NHWWA representing all of you.

Here are two bills that we followed closely and have fortunately moved in the direction we were hoping.

One that we followed closely is **HB691**, text was submitted by prime sponsors House Reps. Peter Schmidt and Judy Aron, titled, *prohibiting the addition of fluoridation chemicals to public water systems*. This bill affects only twelve (12) water systems but affects a vast amount of NH's population. This bill, after its hearing, went straight to Executive Session, which is the meeting to determine whether the bill goes to the House floor or not. During this Executive Session, the committee voted to essentially kill this bill by voting Inexpedient to Legislate (ITL).

Another extremely important bill that we were following was **HB314**, text from prime sponsor Kelley Potenza, titled *prohibiting the use of federal, state, or local funds for lobbying activities*. If this title seems familiar, it's because this bill was put to rest on the floor last year as HB1479. NHWWA closely followed this bill and submitted letters to the committee showing our



opposition. This bill seems targeted to other associations. However, this bill casts such a broad net that all non-profits that support communities with "public funds" would no longer be able to lobby on their behalf. This bill was voted Inexpedient to Legislate (ITL) this session, but I am preparing for this to be back again next year.

What's so special about NH, is the large number of representatives in the House that could possibly change out every two years. Knowing this, we constantly try to build relationships with members of the NH House and Senate to ensure that, for anything water-related, we are the go-to association. We provide the science behind sound decision-making.

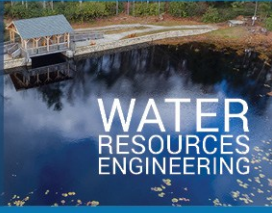
